


## CHICKASHA HS

**No Child Left Behind Act Annual Report Card 2010-2011****Academic Performance Index (API) and Accountability Data**

The API is a numeric score that measures school and district performance based on a variety of educational indicators. It allows schools and districts to gauge their progress toward improving student achievement. 


**State, District and School English II Results**

**State, District and School Algebra I Results**


All Students Tested




