


## WISTER PUBLIC SCHOOLS

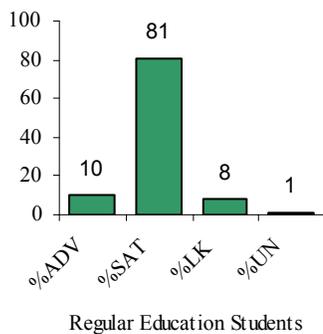

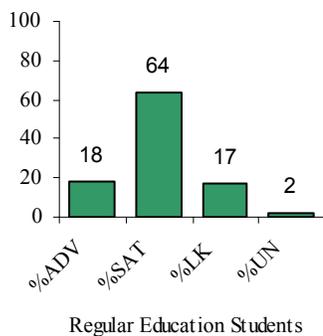






## Trend Data Grade 5 Reading










