









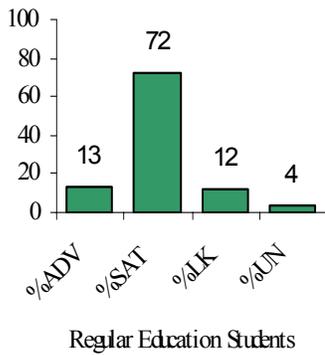





State Results Grade 8 Reading






