

**Academic Performance Index (API) and Accountability Data**






State Results Grade 3 Mathematics







**State Results Grade 5 Mathematics**







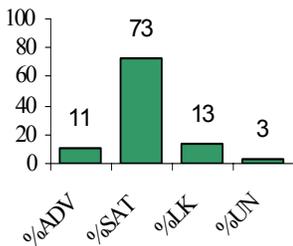








**State Results Algebra**
